PROCEEDINGS OF THE GOVERNMENT OF KARNATAKA

Sub:- Constitution of revised Expert Committee to suggest a roadmap for the strengthening of Farm Universities in Karnataka - reg.,
Read:- Govt., Order No. AD 5 AUM 2012, dated 21-06-2012.

PREAMBLE:-

Consequent to the statement of the Hon'ble Chief Minister in his budget speech of 2012-13, an expert committee chaired by the Additional Chief Secretary to Government and Development Commissioner had been constituted under Govt. Order read above to suggest a roadmap, and ways and means for the strengthening of Farm Universities in Karnataka. Six specific terms of reference had been entrusted to the said committee with instructions to submit the report within 3 months.

2) After further consideration, it has now been decided to re-constitute the said committee and hence the following order.


4) The committee is authorized to utilize the services of any official in the Government or faculty in the 4 Farm Universities as co-opted members.

5) In addition to the terms of reference as laid at in G.O. dated 21-06-2012, the committee shall also undertake:

- a) review and assessment of the existing colleges of agriculture, horticulture, animal husbandry and sericulture.
- b) examination and recommendation to Government, about the feasibility/need to set up new colleges or expand existing colleges.

6) The expert committee shall submit its final report to the Government within 3 months from the date of issue this order.
