**Sub: Constitution of Sub-Committee for adoption of Provisions of
Integrated Agribusiness Development Policy – 2011 in Industrial
Policy – 2009-14.**

Preamble:

The Government of Karnataka has brought out Integrated Karnataka Agribusiness Development Policy 2011 in the G.O. read at (1) above

In the proceedings read at (2) above, it has been decided that the provisions of concessions and incentives spelt out in the Integrated Agribusiness Development Policy 2011 shall be adopted in the Industrial policy 2009-14. In the proceedings read at (3) above, it was noted that only those Agribusiness activities involving processing and some service sector activities are proposed to be adopted in Industrial Policy 2009-14. On these facts a joint meeting was held in the Department of Commerce and Industries with Managing Director KAPPEC on 15/12/2012 on various issues viz, Contents of the Integrated Agribusiness Development Policy 2011, the amendments to be brought about to various acts (Revenue, Agricultural Marketing etc) and the quantum of concessions and incentives proposed to be given to Agribusiness Projects, and it was felt that Government Order read at (1) above needs to be amended suitably vide letter read (4) above. In this regard the proposal of KAPPEC dt: 26/12/2012 read at (5) above has been examined.

Now the Government considers to constitute a sub-committee to suggest the necessary amendments in Integrated Agribusiness Development Policy 2011 and to be adopted in the Industrial Policy 2009-14. Hence the following.

ORDER

For the reasons read in the preamble, the following sub-committee is constituted to suggest necessary amendments in the Integrated Agribusiness Development Policy 2011 including the G.O. No. AHD/172/AFT/2010, Bangalore, Dated: 05/03/2011 and also to suggest the necessary amendments to be adopted in the Industrial Policy 2009-14.
