**PREAMBLE:**

The Government of India in its letter dated:04-07-2014 read at (1) above, has communicated the sanction of Rs.432.00 lakhs to Agriculture Department ,Government of Karnataka towards first instalment of financial year 2014-15 as non-recurring grants-in Aid for implementation of components / schemes of the Centrally Sponsored Scheme National Mission on Food Processing (NMFP) during in the year 2014-15.

In the letter dated: 07-07-2014 read at (2) above, Director of Agriculture and State Mission Director of NMFP has requested to release total amount of Rs.5,76,00,00.00 [Rs.4,32,00,000.00 (Central Share -75%) along with Rs.1,44,00,000.00 State Share-25%]] under the provision of Rs.6.80 crores under the Head of Account:2401-00--102-0-07(051) as first instalment of grants for the year 2014-15.

The State Government has examined the proposal in detail hence the Order.

**ORDER**

1) Government is pleased to accord sanction for the release of Rs.5,76,00,000.00 (Rupees Five crore Seventy six Lakh only) as non-recurring grants-in Aid for implementation of components / schemes as first instalment grant [Rs. 4,32,00,000.00 Central Share+ Rs.1,44,00,000.00 State Share] for the implementation of Centrally Sponsored Scheme National Mission on Food Processing (NMFP) during the year 2014-15.

"THE GRANT- IN- AID BILLS SUBMITTED BY THE MISSION DIRECTOR, NATIONAL MISSION ON FOOD PROCESSING, BANGALORE SHALL BE COUNTERSIGNED BY DIRECTOR OF AGRICULTURE, DEPARTMENT OF AGRICULTURE, BANGALORE".

2) The expenditure in this regard shall be met under the Head of Account:2401-00-102-0-07(051) complying the following.

- The scheme should be implemented according to the NMFP guidelines by following the instructions carefully.
- The scheme shall be implemented at a scheduled period of time and utilization certificate and audited utilization certificate should be submitted without delay.
- As mentioned in KFC the records should be maintained for expenditure made against to the grant allocated / grant released.

3) This order issued in accordance with powers delegated to Secretaries/Principal Secretaries to Government for the release of Central Share for Centrally Sponsored / Central Plan Schemes to administrative Department, vide order no: FD/03/TFP/2014, dated:04-04-2014 and also by confirming the receipt of central share by Credit confirmation slip vide its No:FD 25 BGL 2014, Dated:10-07-2014 received from Finance department.
