May I draw your kind attention to the Office Memoranda quoted under reference, wherein guidelines were issued by the UIDAI HQ mandating use of GPS in the enrolment client. Initially the target date was fixed as 1<sup>st</sup> March, 2017 which was extended to 30<sup>th</sup> March, 2017.

It is however noted with concern that no action has been taken by the CeG to implement these guidelines and the enrolment kits in the field are yet to be equipped with the GPS device.

The matter has been viewed with serious concern by the CEO, UIDAI and I am directed to convey that non-compliance to these guidelines would compel disabling the enrolment machines without GPS w.e.f 1<sup>st</sup> April, 2017.

Thus, I seek your urgent intervention in the matter and issue necessary instructions to all concerned to ensure implementation of GPS in the ECMP/UCL client at an early date.
