With respected to the above Subject and Reference, Regarding admitting candidates to CPS Courses during the year 2020-21, following guidelines have been drawn as par previos years Selection Criteria.

- 1) Candidate must be a domicile of Karnataka.
- 2) Candidate must have MCI recognized MBBS qualification.
- 3) Candidate must possess permanent registration with Karnataka Medical Council.
- 4) Candidate must have appeared for the PG-NEET exam and qualified after additional weight-age of 10 percentile of marks obtained in NEET for every completed year of service up to 30 percentile for 3 years.
- 5) All the students who have passed MCI recognized MBBS examination held by any of the recognized universities or have obtained a qualification mentioned in the above paragraph and are seeking admission into CPS affiliated institution for the purpose of the Diploma/Fellowship of the College of Physicians and Surgeons of Mumbai must provide themselves with certificate of Eligibility form CPS, Mumbai at the time of applying for enrolment as Post-Graduate students.
- 6) All the other eligibility criteria as per HFW, Karnataka.


