\* Explanation under rule 10(1)(a) of the Karnataka State Civil Services (Regulation of Transfer of Medical Officers and Other Staff) Rules, 2011: Where a Government servant of his / her spouse or child ren are suffering from terminally ill cases of serious ailments, for which medical treatment is not available at his/her place of work and his/her transfer is necessary to a place where such a treatment is available so as to provide him/her the required medical treatment. However, no such transfer shall be made unless the concerned Government servant produces a certificate issued by the District Medical Board specifying the nature of ailment, stating the fact that the required treatment is not available at the place of present posting.
